High School Transcript or HiSET/GED Scores

Please submit any previous college transcripts for evaluation.

Prerequisites courses information:

- A grade of 'B' or better in Anatomy and Physiology with Lab I and II and Microbiology with Lab .
- English Composition, College Algebra, Oral Communications, American History OR Government, Introduction to Microcomputer, Health Psychology, and Job Search Strategies.

TEAS score - A minimum composite score of 60 is required. To schedule your test, go to <http://www.statetechmo.edu/contact-admissions/testing/>. This test must be taken within five years of application submission and can be taken 3 times in an admission cycle. Current State Tech PNT students should verify their score is on file with admissions.

- Test scores may be waived with approved transfer credit
