High School Transcript or HiSET/GED Scores

Please submit any previous college transcripts for evaluation.

Education records – Submit all official transcripts including college transcripts for dual credit courses taken in high school.

Test scores – Submit all ACT and/or Accuplacer NextGen test scores:
• Test scores are used for program admittance and course placement
• Test scores may be waived with approved transfer credit

Certificate Requirements:

- English: 251
- Reading: 250

TEAS Test Scores – A minimum composite score of 60 is required. To schedule your test, go to <http://www.statetechmo.edu/contact-admissions/testing/>. This test must be taken within five years of application submission and can be taken 3 times in an admissions cycle.

Total of four hours of documented Observation Experience with a Licensed Practical Nurse (LPN) or Registered Nurse (RN). The observation will not be accepted if completed at the applicant's current place of employment. Both forms (Applicant Initial Set-Up of Observation Form.pdf and (Applicant Observation Form.pdf) need to be completed and submitted to the Office of Admissions.
